RESPONSIBILITIES

- Preparing audits and inspections to detect existing or potential accidents and health hazards that determines corrective or preventive measures were indicated and followed-up with contractor to ensure measures have been implemented.
- Coordinating and conducting internal HSE audits, ensuring that non-conformities are closed out as per agreed time scales.
- Reviewing, implementing, and auditing the Management System to ensure ongoing compliance with SMS and relevant legislations.
- Assisting with developing the HSE plans that comply with policies and procedures as well as client requirements.
- Working closely with the client's quality unit to identify and take remedial actions in areas where safety can be improved.
- Attending incident investigations and ensuring the HSE guidelines are both understood and complied with.
- Investigating and completion of process for the close out of all accident investigation reports.
- Coordinating with the external auditors & clients to conduct the required inspections and audits and ensures that non-conformities are closed out as per the agreed timeframes.
