- Evaluation selection and control of sub-contractors to ensure that Subcontractors are fully aware of their safety obligations and are in fact meeting them.
- Co-ordinate with Client Organization and organize for Safety orientation Program for all
- employees whom may be allotted to work at that organization

- To ensure all employees wear general required Personal protective Equipment's, depending on their job including arranging special safety gadgets like full body harness to work at elevations, chemical resistant gum boots, Aprons, for Acid pickling personnel.
- Conduct daily Safety Orientation briefing, Safety awareness to all workmen before start each shift.
- Continuously monitor conforming to Safety Rules and Regulations.
- Recommending to management for punishment to habitual violators including termination.
- Attend Safety co-ordination Meetings and brief regular to workmen about salient features of Safety.
- To cultivate a calmer of Safety and Health awareness of the workmen.
- Report and investigate all accidents promptly and arrange for First Aid where ever it is an immediate requirement.
- Prepare safety Audit monthly report to the client and the quality management.
- conduct breathing apparatus training for workers assigned to work iii Toxic environment. Assist the Pre-commissioning / commissioning team to perform their task safely.
- Implementation safe working system and advice ways to improve existing worked methods. Fire Extinguisher bottles on scheduled inspection periods and service them in needs.
- To insure safe posters, boards and other required charts are placed on installations.
- Site indoctrination and advising on safety measure to new employees.
- Monitor housekeeping in all relevant areas.
- inspect *firefighting equipment* / fire alarm and fire control system.
- Before leaving the job site, make sure that all unfinished job as open pit, overhead and other must have safety precaution of signboard and safety tape to avoid accident.
- Monitor all site activities to ensure that all safety procedures are followed perfectly. Safety audit on site, instruction and training the company and contractor staff.
- make daily reports and submit to immediate supervisor. Brake necessary work permit whenever to begin the job.
- Accident incident investigation and reporting.
- Daily, weekly, monthly, quarterly inspection and monitoring all activities and facilities. Carry out surprise checks on site to determine effectiveness and adequacy of systems for safety.
- Coordinate fire drill, drivers training and safety realtor meetings.
- Monitor all workers if they are proper safety outfit and always keep in touch with all workers to remind safety
- supervision of all construction works on site preparation and conducting training for all company and contractors.
- Conduct gas test to ensure sufficient Oxygen percentage and absence of toxic and hazardous gases in confined space before entering for work.
- Preparation of accident, incident & near miss reports, the root cause for the accidents and preventive measures.
- To import training to all workers & staff regarding the emergency evacuation procedure. Plan safety publicity program and order posters, visual aids, signs etc.
- Establish and maintain site Emergency Tern.
- Development, implementations, enforcement and administration of safety health hazards

requirements in accordance to safety standard.
