

- Support the team with planning, coordinating, and implementing of effective HSE policies, guidelines and procedures to ensure that the department objectives are met.
- Attend pre-job, planning and client meetings as required on HSE related matters.
- Assist with developing HSE plans that comply with company policies and procedures as well as client requirements.
- Evaluated the HSE performance of the Contractor and site team using the agreed KPIs and other means and recommended improvement opportunities.

- Participated in incident investigations and reporting, including initial incident notification to project leadership.
- Engaged in Contractor and Sub-contractor HSSE reviews and audits.
- Ensure training, toolbox meetings, drills are implemented as part of company's training and HSE plan, i.e. Emergency response system.
- Manage safety statistic reporting, track and provide regular HSE performance reporting to the dept. head.
- Investigate and complete the process for close out of all accident investigation reports and prepare/submit lessons learned to the regional HSE manager for promulgation to the management.
- Participate in all site safety committees and analyse all job hazard activities and ensure compliance to all OSHA guidelines and perform audit on all activities.
- Conduct pre-operational risk assessments on new sites and design risk mitigation measures.
- Review and analyse accidents and near-miss incidents and make corrective action recommendations.
- Provide input to the Leadership Team on HSE matters.
- Confirm that contractors effectively implement HSE Plans and conform to terms and conditions.
- Intervene and stop work for unsafe acts or conditions as needed.
- Effectively communicate and interface with the Project, Construction, and corporate HSSE manager
- Monitor performance of contractor's site management personnel to ensure alignment with contractor's internal HSE standards and HSE requirements.
- Ensure to Conduct the HSE trainings and orientation to all new employees.
- Monitor advice and assist to ensure that safe systems of work and procedures are adhered to.
- Inspect all passageways, stairs and fire exists to ensure that they are free from obstructions and comply with the relevant legislation.
- Monitor that the respective personal protective equipment is being worn relevant to the task being performed.
- Monitoring all firefighting equipment on monthly basis and record.
- Ensure that there are appropriate and sufficient safety signs in the department.
- Ensure that all evacuation assembly points are maintained and contain the relevant instruction/ procedures.
- Ensure and verify actions on request for action are taken.
- Inspection of all safety equipment's such as PPE, safety harness, fire extinguishers etc.
- Checking the entire safe work plan prior to commence the work.
- Checking of scaffold materials before and after installation.
- Monitoring the necessary work permit prepared before beginning the job.
- Inspection of all cranes, heavy equipment and lifting Accessories.
- Conduct Safety meetings.
- Monitor Permit to Work System,
- Prepare daily and weekly site inspection report.
- Monthly inspection reports prepared.
- Advice site supervision on corrective action to be taken to all safety deficiencies observed on site.
- Ensure color coding inspection for all equipment's and tools are being implemented on site.
