- Ensure that all incidents are reported immediately. Investigate and complete the process for Close out of all Accident Investigation Reports and prepare/submit HSE Management.
- Participate and assist the Operations Manager and Site Person In charge in the investigation of incidents to determine root cause, and corrective actions where necessary and ensure incident corrective actions are followed up on and completed.
- Review job site safety compliance inspections including hazard analysis, safe work procedures and write reports and recommendations.
- Direct and review analysis of accident and injury data, identifying the needs for new or modified occupational safety programs.
- Research occupational safety information to assure the best available methods and equipment are adopted to minimize the hazards in the workplace.
- Advise on improvements in tracking and reporting procedures.
- Provide support to Project team in all aspects of safety, occupational health, safety, and environmental issues. Provide support to the department on the implementation of companywide HSE initiatives. Provide direction, support and resource to all site managements, Engineers / Supervisors and Sub Contractor Safety Personnel.
- Ensure training, toolbox meetings, and Emergency drills are implemented as part of the company's HSE Program, i.e., emergency response systems, etc.
